Who we are...

- The Community Dreamer Fund was established by CSU DACA and undocumented students in partnership with Sojourn Mennonite Church following the 2017 rescission of DACA.
- We provide emergency assistance to undocumented, DACA and asylumseeking high school and college students in Larimer County. We help students overcome financial obstacles so that they can complete their education and attain their professional goals.
 - Colorado State University, Front Range Community College, Poudre School District and Thompson Valley School District high schools
 - Rent, food, legal fees, DACA renewals, school tuition and exam fees, medical and mental health needs, vehicle repairs, etc.
- We are student-and community-responsive coalition which allows us to quickly identify and respond to emergent needs expressed by students in Larimer County.

Undocumented and DACA Students...

- What is Deferred Action for Childhood Arrivals (DACA)?
 - Created to protect eligible young adults who were brought to the US as children from deportation and provide them with work authorization for temporary, renewable periods of two years. (\$495 fee for renewing)
- Be prepared for DACA to end. The Fifth Circuit Court in Texas is expected to rule on the future of DACA any day now. Immigration experts believe the case will continue to the Supreme Court and will be struck down.
- What does it mean to be undocumented?
 - Extremely vulnerable group of students
 - No social security number or work authorization
- Many complex reasons why they may not be eligible for documentation
 - New DACA applications are no longer accepted
 - Asylum seekers, new arrivals, can't afford lawyers, etc.
- Perpetuates a "Good" vs "Bad" immigrant narrative that someone did something right and someone did something wrong. Immigration legal systems is a patchwork of complicated laws providing multiple reasons why someone doesn't have documented status.

Why our support is important...

Despite the contentiousness of current immigration politics, every student in the United States is guaranteed a free public education (*Plyler v. Doe*, 1982).

- Many of the undocumented and DACA students in Larimer County were raised in our public education system and recruited by our colleges and universities. The "American Dream" is instilled in them.
- Due to their status, they are not eligible for student loans and traditional types of support offered to other students to help them close the financial gaps between their school commitments and living expenses.
- Students constantly struggle to find affordable housing and often rely on parents and emergency resources like the Community Dreamer Fund to narrow their financial gaps.

Why our support is important...

- Diverse staff prepared to deal with cultural nuances in the workplace. They are "change-ready."
- Highly educated and trained with many masters and post doctorate degrees.

How we raise funds...

- We conduct community outreach and fundraising events to raise awareness about the experiences of DACA and undocumented students in Larimer County. We've distributed over \$137,000 to 167 applicants.
- We rely on individual donations (62%)
- A third of our funding comes from grants (38%)
- All funds go directly to students. We are entirely volunteer operated.

The need among students is growing...

Since January, the rate of applications has increased from approximately \$2700 a month to \$4200 a month.

Historically, we raised ~\$30,000 annually to fulfill requests. Based on the increase in applications, we need to raise \$45,000 in 2023.

CDF is known and trusted in the community.

Organizations like CSU refer students to us when there is no other place for a student to go for emergency assistance.
