### Estes Valley Community Fund – Grant Guidelines

The Community Foundation of Northern Colorado creates transformational community impact by inspiring philanthropy and engaging the region. We value fostering collaboration and inspiring community action, serving as a trusted steward, and creating a more engaged, philanthropic, & visionary community.

#### Grantmaking goals

Through its grantmaking, the Foundation aims to:

- Support strategic, transformational, or catalytic projects
- Support high-impact work resulting in meaningful outcomes
- Encourage collaboration among nonprofit organizations

#### Community-specific priorities and guidelines

In addition to the broadly stated Foundation goals above, the **Estes Valley** community funds have additional specific priorities and guidelines.

- Grants awarded from the **Estes Valley** community funds must be used for the benefit of residents of **Estes Valley**.
- Organizations may apply for a grant up to \$15,000; however, grants awarded in recent years have ranged from \$500 - \$10,000.
- In addition to the broadly stated Foundation goals above, special funding is available for:
  - Affordable/workforce housing
  - Vulnerable families and individuals
  - Big Thompson Canyon history, preservation, recreation, and education

#### Eligibility

The Community Foundation makes grants to 501(c)(3) charitable entities, educational institutions, churches, or government entities that are in good standing with the IRS. If you are group, club, association, or organization that does NOT fit these criteria, but are seeking funding for a charitable project, consider partnering with a 501(c)(3) or government agency that can be your fiscal sponsor and apply on your group's behalf. This grant opportunity is available to these types of entities serving the community of **Estes Valley**.

The Foundation typically does not fund:

- Individuals
- Businesses/for-profit companies
- Political lobbying/candidate campaigns for political office
- Sponsorships, tables, or tickets for special events or fundraising events
- Debt retirement/deficit financing
- Private foundations

Due to limited funding available, nonprofits should not expect or depend upon receiving grant support. Preference will be given to organizations that have not received a grant in the last 12 months. In addition, organizations may only apply to one community fund per cycle.
